# Wilke Family Preserve

Management activities are underway for the new Wilke Family Preserve north of Waunakee. The wetland surrounding the tributary of Six Mile Creek shows some promise. Currently, it is full of reed canary grass which chokes out native plants; however, several small fen areas harboring sedge and rush species are giving preserve intern, Sherri Laier, plenty of practice in plant identification. We have also located a very active spring on the property which is sending lots of clear, cold water into Six Mile Creek.

Sherri is carrying out a weekly plant inventory to see what species are present. She, and Madison Audubon's Goose Pond interns, Bert Jumbeck and Brian Margelofsky have transplanted a couple hundred plugs of cordgrass and sawtooth sunflowers along the wetland edge. Sherri has also been collecting seed from early blooming plants like Blue-eyed Grass, Spiderwort, Panicum, Needlegrass, Shooting Star and Phlox to plant either this fall or next spring on the uplands which are now in corn.




