Robert will use a portion of the 36 acres recently acquired by Groundswell for a program called Farming After Incarceration Release, or FAIR. The idea is to engage recently-released felons in urban agriculture to create economic opportunity for them and their families. "Growing food can change the perception of how people see themselves," says Robert, executive director of the nonprofit Neighborhood Food Solutions. Robert will also use a portion of the land for his Program for Entrepreneurial Agricultural Training, or PEAT, which aims to get a younger generation involved in the urban farming movement. It includes a summer employment program that provides an opportunity for low-income or at-risk teens to learn new skills. "We've had to move around a lot," Robert laments. "I've gained land, lost land, but never had any of my own."

That's where Groundswell comes into the picture. "What we can offer Robert is land security," said Jim Welsh, Groundswell's Executive Director. In December, Groundswell purchased the 36 acres from fourth generation landowner Brian Pasley. Money for the purchase was provided by a combination of the Dane County Conservation Fund, Knowles-Nelson Stewardship Program, the estate of Marie Fraser, several anonymous donors, and Groundswell.

"You have two goals accomplished here. You're protecting an important natural area and making sure farmers, in this case farmers of color, have access to land", said Jim Welsh.



More to love at Patrick Marsh

Dineo Dowd loves Patrick Marsh. "It's like a dream come true to live right next to such beautiful land. The trails are well maintained and it's a peaceful land to walk all year around." Dineo should know; she and her family are Sun Prairie residents and avid explorers of great local places. She is also the Madison representative for Hike It Baby, an organization dedicated to getting families together in nature with birth to school-age kids. And the good news is that in October we purchased 25 acres on the northwest side of Patrick Marsh. The land

occupies a low hill rising above the wildlife viewing platform and main trail into the wildlife area.

The City of Sun Prairie will be the long-term owner of the property. Sun Prairie Mayor Paul Esser has been a strong advocate for adding this land to Patrick Marsh. "I am so pleased that the purchase has been finalized. This addition to Patrick Marsh will benefit the people of northeast Dane County for years to come while providing much needed habitat for many members of the wildlife community."

Groundswell, Patrick Marsh Conservancy, and our volunteers will partner with the city to plant the land to prairie. It is also a great place to add a scenic overlook and trail tying into the existing trails at the marsh. If you'd like to help with the restoration, please contact Tony@groundswellwisconsin.org.

Landowners protect beloved farms


Thanks to the leadership of two families, in December the Town of Dunn and Groundswell added two more farms to the Town's Rural Preservation Program.

One of these newly protected farms is owned by Roz and Bill Gausman, long-time dairy farmers in the Town. Their pasture-based dairy operation was ahead of its time and their milk has been used to make artisan cheeses here in southern Wisconsin.

Over the last 21 years, our partnership with the Town has resulted in the preservation of 30 farms totaling more than 3,200 acres of prime farmland, woodlands, and wetlands.

Our sincerest thanks go to the landowners who have permanently protected their farms for future generations. The USDA Natural Resources Conservation Service provided important funding to purchase the agricultural conservation easements protecting the farms. And thanks to the residents of the Town of Dunn who have made their Rural Preservation Program an amazing success and funded these easements with their own tax dollars.





Eagle conservation soars

Rivers connect places—and places connect people. One of these special places is Ferry Bluff State Natural Area, a critical winter congregating area for bald eagles within the Lower Wisconsin State Riverway. There are only three winter concentrations in all of Wisconsin, and Ferry Bluff is the only communal roost on the Lower Wisconsin River that has gained significant long-term conservation protection.

Last November, with help from the Ferry Bluff Eagle Council—the nonprofit group that performs eagle research, develops educational programs, and leads eagle-watching tours—Groundswell purchased a 31-acre parcel of land adjacent to Ferry Bluff. The conservation minded landowner wanted the land to remain natural and undeveloped for the benefit of the entire community. We hope to donate the property to the state as an addition to the state natural area.

Thank you to the individuals, businesses, and foundations listed on our website at groundswellwisconsin.org/ferrybluff who contributed half of the funds to purchase the property. The other half of the funds came from the State of Wisconsin Knowles-Nelson Stewardship Program.

Persistence pays off in Oregon

Overlooking the Village of Oregon lie 59 acres of rolling fields and forest. Landowners Pat and Patricia Hermsen bought the property in 1984 and have thoroughly enjoyed this special place since then. But it wasn't enough for Pat and Patricia to just enjoy the property; they wanted to ensure that future generations in the community would be able to relish this area, too. A public conservation park would be an ideal way to do that.

"We thought that by donating this land other people could use it as well as we can for entertainment, and relaxation, and education," said Pat Hermsen. To start the process they reached

out to Groundswell Conservancy to help them achieve their goal. Sometimes, conservation easements happen quickly. This easement took almost four years of persistence. Pat and Patricia kept focused on their vision until finally, on December 11th, their property was permanently protected.

The Hermsens intend to donate the property to the Village for a park when they no longer live there. The conservation easement will ensure that the land remains undeveloped as a conservancy park. Their generosity and persistence will be a boon to the community for years to come.
